KBA Consulting Management Limited (the "Manager") is the UCITS Management Company appointed by the Fund. The Manager is authorised in Ireland and regulated by the Central Bank of Ireland.

WHAT IS THE PRODUCT?

Type: The Sub-Fund is a sub-fund of the Fund, an open-ended umbrella investment company with variable capital with segregated liability between its sub-funds and is established as an Undertaking for Collective Investment in Transferable Securities (UCITS).


Term: This product is not subject to any fixed term.

Objectives: The investment objective of the Sub-Fund is to achieve medium to long-term growth through investment primarily in growth oriented Indian stocks which are listed on the BSE (formerly Bombay Stock Exchange) and the NSE (National Stock Exchange) in India. The Sub-Fund intends to achieve its investment objective by investing on a permanent basis more than 75% of its Net Asset Value in a diversified portfolio of equities and equity related securities of (i) large, mid and small-cap corporations that have their registered office in India and are listed on Recognized Exchanges worldwide, (ii) large, mid and small-cap corporations that exercise a preponderant part of their economic activity in India and are listed on Recognized Exchanges worldwide and/or (iii) large, mid and small-cap corporations whose equity and equity related securities are listed, traded or dealt in on Indian stock exchanges listed in Appendix II of the Prospectus. The investment in securities which are listed on Recognized Exchanges other than BSE and NSE will not exceed 25% of the Net Asset Value of the Sub-Fund. The Sub-Fund may invest in securities which are not constituents of the Benchmark. The Sub-Fund falls within the meaning of Article 8 to the SFDR. The Sub-Fund is considered to be actively managed in reference to the MSCI India Index (the "Benchmark") by virtue of the fact that it uses the Benchmark for performance comparison purposes only. The Benchmark is not used to define the portfolio composition of the Sub-Fund and is not used as performance target. Shareholders may redeem their Shares on a Dealing Day at the Net Asset Value per Share calculated as at the Valuation Point in relation to that Dealing Day. No fees or penalties are applied by UTI International (Singapore) Private Limited. Intended Retail Investor: Typical investors will be (i) those who are particularly knowledgeable in investment matters, in particular financially sophisticated high net worth individuals and institutional investors and (ii) retail investors. An investment in the Sub-Fund is only suitable for investors who are capable of evaluating the risks and merits of such investment and who have sufficient resources to bear any loss which might result from such investment. The NAV per share is calculated in US Dollars and settlement and dealing will be effected in the class currency of the relevant share class. The NAV per share of the Sub-Fund will be published daily and made available on www.bloomberg.com and will be updated following each calculation of the NAV. The assets of this Sub-Fund are segregated from other Sub-Funds in the Fund, meaning the liabilities of one Sub-Fund cannot impact another Sub-Fund.

WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

Summary Risk indicator



Lower risk
